Schedule B

List of the conditions and/or constraints applied by ITSO.

- This POST does not support operating in a closed system
- LOC4 format is not supported by the POST for usage transactions
- POST does not support Sale price table usage because of the fares engine that Parkeon uses does not require this feature
- Set based Class2 messages are not supported by the POST
- Action To Take code 15 (0x0E) is not supported by the POST
- Changing the STR owner before first use is not supported as this POST operates in an uncontrolled environment
- This POST does not allow IPEs to be automatically selected based on best value fare however, the best value fare can be manually selected
- When a CM is prematurely removed & represented, the POST does not continue the transaction from the interruption point, but starts a new transaction
- The POST does not support requesting messages from a HOPS by individual message class, or by ISAM group
- The POST proxy does not request downloads of individual class files. The class parameter is not used, use of a proxy and the ISAMs are all on remote (non-static) devices.

Optional functionality not supported:

- The optional messages 0Exx & 0Fxx (User Defined message), 0310 & 0801 (Supplementary Data message) and 0807 (Additional Shell Data message) are not supported
- The creation of long (HASH-sealed) messages is not supported
- The POST does not support the optional controlled download request, as it operates in an uncontrolled environment
